We are required by federal mandate to obtain your membership opt in before we can provide you with service on your account(s). As of <u>September 1, 2024</u>, you currently do not have access to the following products or services until you opt in:

- Servicing your loan
- · Making an advance of funds from an open line of credit
- Opening a new account, loan, or safe deposit box
- Adding a joint party or new signer to an existing account
- Adding or removing account beneficiaries
- Receiving a first-time debit card for an open checking account
- Purchasing a money order, cashier's check, or VISA gift card
- Receiving signature guarantee or notary public services
- · Redeeming a U.S. savings bond.

Like the FDIC, the NCUA will insure your accounts at MSUFCU up to \$250,000, per member, per ownership category. NCUA share insurance is backed by the full faith and credit of the U.S. Government.
